Dear Stakeholder:

Re: **2007 Tariff Consultation — Update and Schedule**

In April and May the AESO distributed preliminary reports on the 2006 Cost Causation Study and Customer Contribution Policy Study being completed as part of preparations for its 2007 tariff application. Stakeholders have provided comments on those reports, and based on the comments the AESO has proceeded with additional work on both studies as well as on other areas of tariff development. The AESO is now planning the final steps in the 2007 tariff development in anticipation of filing its 2007 tariff application in late July.

The AESO expects to complete stakeholder consultation and file its 2007 tariff application as follows:

- Thu, Jun 22 **Final study reports and discussion papers** distributed by the AESO on 2007 rates and 2007 terms and conditions.
- Thu, Jun 29 **Consultation meetings** to review and discuss study results and the rates and terms and conditions proposals in the discussion papers. These meetings will be held from 9:00 am to 12:00 noon for rates matters, and from 1:30 to 4:30 pm for terms and conditions matters. Both meetings will be held at the Telus Convention Centre, Room Glen 209 (South Building), in downtown Calgary.
- Tue, Jul 10 **Stakeholder comments** submitted in response to the study reports, discussion papers, and discussion at the consultation meetings.
- Week of Jul 24 **AESO 2007 tariff application** filed with EUB.
