Re: **AESO 2007 Tariff Consultation — Stakeholder Meeting**

The AESO invites you to participate in a stakeholder meeting to review the AESO's draft 2007 tariff application and discuss stakeholder concerns that have been raised to date in the 2007 tariff consultation process.

Meeting details are as follows:

Date: Thursday, September 21, 2006
Time: 9:30 am – 12:00 noon and 1:30 – 3:00 pm (lunch on your own)
Location: Telus Convention Centre, Rooms Glen 202–204 (South Building),
120 – 9th Avenue SE, Calgary
Refreshments: Beverages and snacks will be provided

Note that the date has been changed from the previously proposed date of September 20 to avoid conflict with other external meetings scheduled for that day.

Rates-related topics will be covered in the morning session, and terms and conditions-related topics in the afternoon. However, depending on discussion and questions from stakeholders, this timing is flexible and the meeting will be extended if warranted.

The meeting will focus on changes to the AESO's 2007 tariff proposals since the June 29 stakeholder presentation and discussion of matters raised by stakeholders since then, including the AESO's response to those matters. The AESO continues to invite written comments from stakeholders on their concerns with the 2007 proposed tariff. All written comments will be posted on the AESO's website prior to the stakeholder meeting.

Stakeholders are invited to attend either or both of morning and afternoon sessions on September 21. Stakeholders should indicate their participation by 4:00 pm on **Tuesday, September 19, 2006**, by contacting Stakeholder Relations by e-mail at stakeholder.relations@aeso.ca or by phone at (403) 539-2588.

The AESO will distribute a draft of its 2007 tariff proposals (including some changes beyond the draft distributed on July 21) to stakeholders no later than Monday, September 18, 2006. A formal
