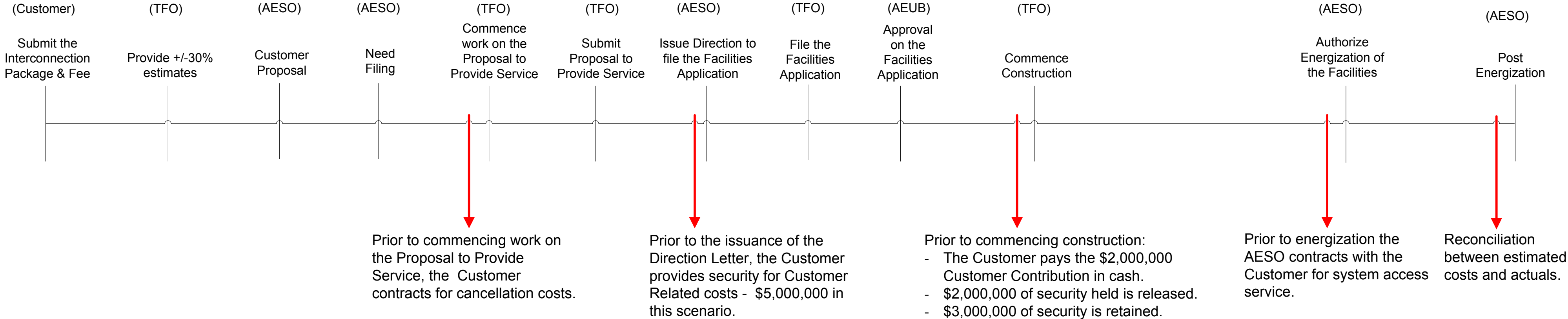

 - Customer costs not eligible for the AESO investment policy (Customer Contribution) - \$2,000,000

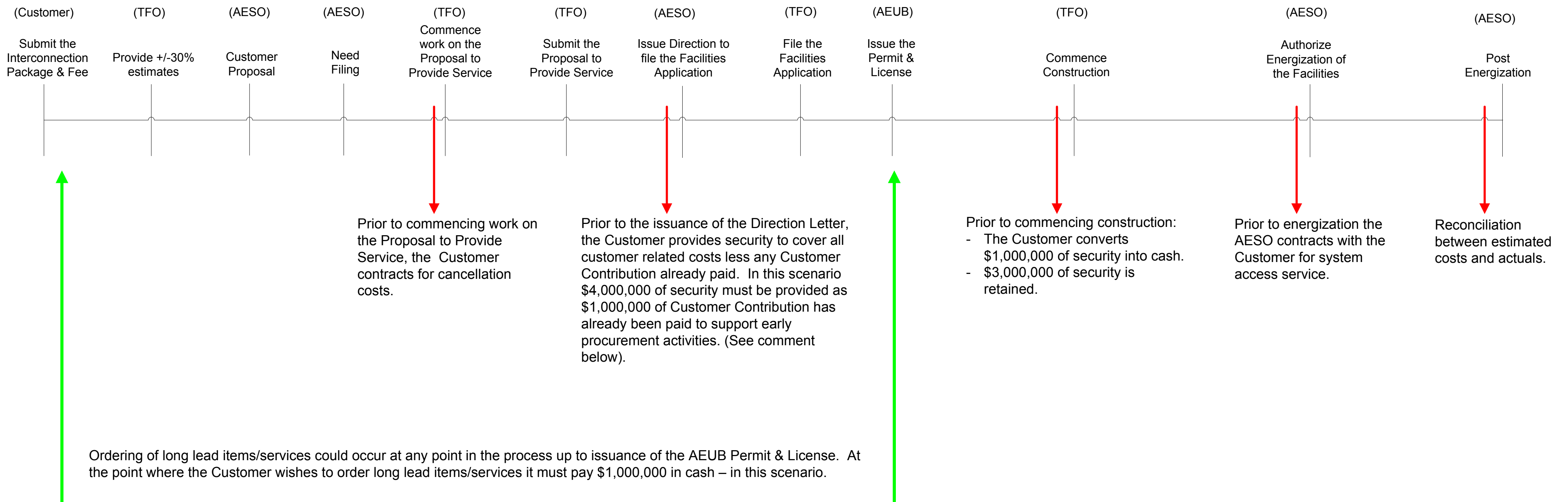
Scenario – Ordering of Long Lead Equipment/Services prior to AEUB Permit and License

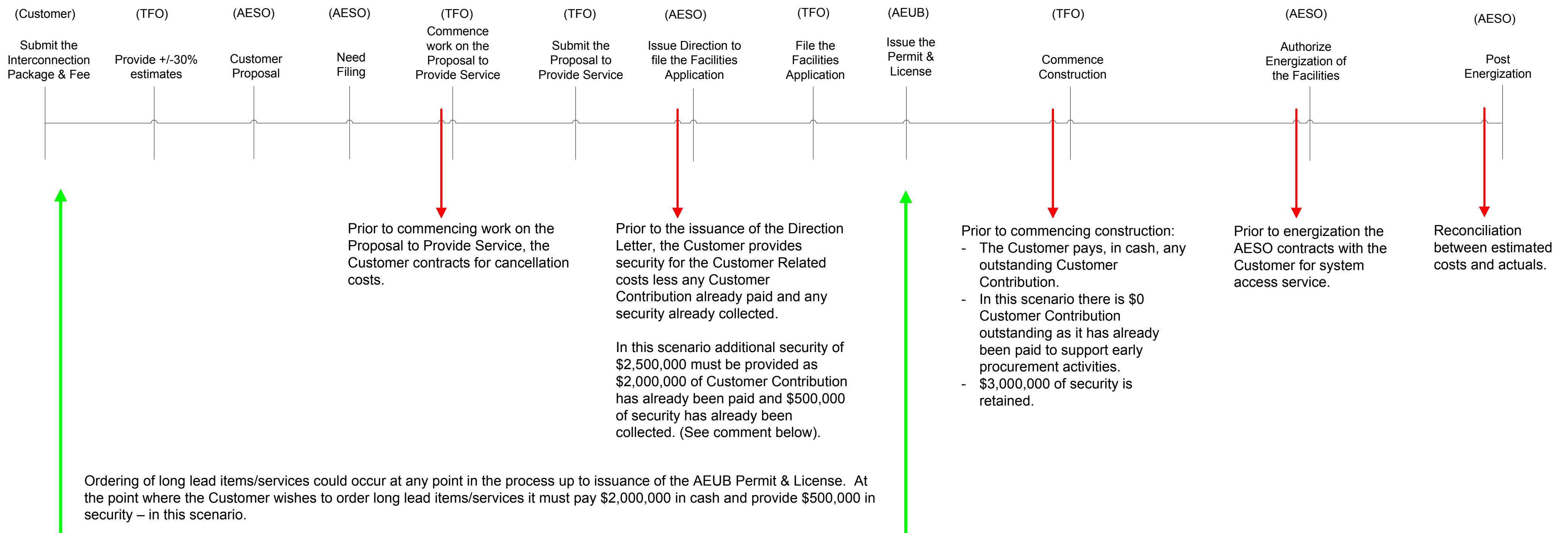
Scenario – Ordering of Long Lead Equipment/Services prior to AEUB Permit and License where the amount exceeds the customer contribution amount.
