The Market Surveillance Administrator, Market Participants and Other Interested Parties ("Stakeholders")

Re: Invitation for September Stakeholder Consultation Sessions on Draft Proposed Amendments to ISO Rules and Definitions to Enable Energy Storage ("Energy Storage ISO Rule Amendments")

Further to the July 22th, 2022 Save the Date posted on the Alberta Electric System Operator's ("AESO") website, the AESO is now providing Stakeholders with registration details for the Stakeholder consultation sessions on September 13, 2022 and September 26, 2022.

The AESO originally planned to conduct two separate sessions on September 13, 2022, offering Stakeholders the ability to attend the session that are of interest to them. After further consideration, the AESO has decided to merge the Stakeholder sessions 1 and 2 into a single all-day session ("September 13th Session") because, in several instances, the aggregated facility topics are foundational to the understanding of the applicability and clarification of the technical ISO rules.

The AESO considered the Stakeholder survey results in determining the format for the Stakeholder sessions. The September 13th Session will be a hybrid in-person/virtual format and the September 26th session will be conducted virtually. The registration details for each of the stakeholder sessions are provided below.

Though the registration link. Stakeholders will be asked to indicate whether they will attend the September 13th session in-person or virtually. If the majority of Stakeholders plan to attend the September 13th session virtually, or if in-person registrations exceed room capacity limitations, the AESO may move to a virtual-only format. The AESO will confirm this decision on or before August 30th, 2022.

Stakeholder Consultation Session Details

The AESO anticipates posting the session agenda, presentation for the September 13th Session, along with the AESO's written responses to stakeholder comments, on September 2nd, 2022. The AESO recommends that Stakeholders review all materials in advance of the session.

If certain comments and questions were not sufficiently addressed by the AESO through written responses, or in the September 13th Session, Stakeholders are welcome to raise outstanding issues at the September 26th Open Forum Q&A.
