Effective July 1, 2011 the timeline is one month (initial), two months (interim) and four months (final) after the end of the settlement period. <sup>2</sup> The Dispute Submission Period is a period of twenty business days following the issue date of the final energy market statement. If there is a disagreement with the settlement amounts after the final energy market statement date, then a written dispute must be filed with the AESO within the Dispute Submission Period. The rules regarding disputes can be found in the Market Participation Rules for the AESO.
