Re: **Invitation to Technical Meeting to Present Recalculated 2018 Loss Factors Determined Under Section 501.10 of the ISO Rules, *Transmission Loss Factors* (“Loss Factor Rule”)**

The AESO anticipates publishing recalculated 2018 loss factors in the week of April 23-27, 2018. The loss factors will be determined under the Loss Factor Rule that became effective on December 7, 2017.

The AESO expects the recalculated 2018 loss factors to first be used for billing of system access service under Rates STS, XOS, IOS, and DOS on statements of account issued in May 2018 for initial and interim settlement of April and February 2018, respectively.
