## Notice of Intention to Forward Amendments to previously approved BAL-003-AB-1.1, *Frequency Response and Frequency Bias Setting* and rename as BAL-003-AB1-1.1, *Frequency Response and Frequency Bias Setting* (“Amended BAL-003-AB1-1.1”)

On June 19, 2019, the AESO intends to forward the proposed amended BAL-003-AB1-1.1 to the Alberta Utilities Commission (Commission), pursuant to Section 19 of the *Transmission Regulation*, recommending that the Commission approve the amendment of the reliability standard.

Section 19(4) of the *Transmission Regulation* states that, before a reliability standard is adopted or retired in Alberta, “the ISO must consult with those market participants that it considers are likely to be directly affected”. The amended BAL-003-AB1-1.1 applies only to the AESO. Therefore, the AESO is not consulting with market participants on the adoption of the amended BAL-003-AB1-1.1.

The amended BAL-003-AB1-1.1 is proposed to become effective upon approved by the Commission.
