Re: Application of the Alberta Electric System Operator (AESO) for Cancellation of the Needs Identification Document Approval of the ATCO Power Heartland Generating Station Connection

Introduction

Pursuant to Section 10 of the Alberta Utilities Commission Act, the AESO is applying to the Alberta Utilities Commission (Commission) for cancellation of Needs Identification Document (NID) Approval 22596-D02-2018¹ (NID Approval).

Background and Relief Requested

In Decision 22596-D01-2018,² issued February 7, 2018 the Commission approved the AESO's NID application³ and issued a NID Approval approving the need to connect the ATCO Power Heartland Generating Station to the Alberta interconnected electric system by adding one 240 kilovolt (kV) circuit and modifying the existing Josephburg 410S substation, including adding one 240 kV circuit breaker.

The NID application was submitted by the AESO in response to a request received from ATCO Power Canada Ltd. (ATCO Power) for system access service to connect its approved ATCO Power Heartland Generating Station, to be located in Strathcona County, near the City of Fort Saskatchewan.

On May 6, 2019 the AESO received correspondence from ATCO Power confirming that there is no longer a need for system access service for the approved ATCO Power Heartland Generating Station. A copy of ATCO Power's notification is attached to this letter as Attachment 1. On June 28, 2019 ATCO Power filed an application with the Commission to cancel the approval for the ATCO Power Heartland Generating Station and the permit and licence for the Lamont 400S substation.⁴ On July 18, 2019 the Commission

granted ATCO Power's application to cancel the approval for the ATCO Power Heartland Generating Station and the permit and licence for the Lamont 400S substation.⁵

In accordance with the NID Approval which states that "the Commission may review this approval, in whole or in part, upon its own motion or upon application by an interested party, in accordance with Section 10 of the *Alberta Utilities Commission Act*," the AESO is applying to the Commission for cancellation of the NID Approval pursuant to Section 10 of the *Alberta Utilities Commission Act*.

Directions to AltaLink and Request to Combine

On September 30, 2019, the AESO directed the transmission facility owner, in this case AltaLink Management Ltd., in its capacity as general partner of AltaLink, L.P., (AltaLink) to apply to the Commission for cancellation of the facilities-related approvals that were granted as a result of this NID Approval, no later than 30 business days after having received the NID Approval cancellation application from the AESO. The AESO and AltaLink have agreed to coordinate submission of this application with AltaLink's application for cancellation of the applicable facilities-related approvals, and the AESO requests that the Commission combine and consider the applications in a single proceeding as contemplated by Section 15.4 of the *Hydro and Electric Energy Act*.

Stakeholder Notification

With respect to stakeholder notification, Section 4(b) of Appendix A2 of Rule 007: *Applications for Power Plants, Substations, Transmission Lines, Industrial System Designations and Hydro Developments* states that "[i]n the event that the [AESO] decides not to proceed with a needs identification document application or an abbreviated needs identification document application for which a stakeholder notification has been distributed, the [AESO] must notify stakeholders of this decision in writing."

The AESO has directed AltaLink to assist the AESO in providing notification to previously notified stakeholders who were part of the participant involvement program⁶ conducted by the AESO. The AESO developed a one page cancellation notice to be distributed by AltaLink to previously notified stakeholders. A copy of this cancellation notice was posted to the AESO website at https://www.aeso.ca/grid/projects/heartland-generating-station-interconnection/ and a similar notice was published in the AESO Stakeholder Newsletter on July 4, 2019. Copies of the cancellation notices on the AESO website and in the AESO Stakeholder Newsletter have been included as Attachments 2 and 3, respectively. AltaLink has advised the AESO that it has mailed out its project cancellation letter and the AESO's cancellation notice on June 26, 2019. Both of these documents were also posted on the TFO's project-specific webpage at http://www.altalink.ca/projects/view/21/atco-power-heartland-generating-station-interconnection on June 26, 2019. A copy of AltaLink's project cancellation letter has been included as Attachment 4.

AltaLink has advised that stakeholders have not identified any concerns or objections regarding the cancellation of the system access service request for the ATCO Power Heartland Generating Station. Similarly, the AESO has not received any indication of concerns or objections about the cancellation of the system access service request for the ATCO Power Heartland Generating Station.

Project background

The ATCO Power Heartland Generating Station Interconnection was intended to connect ATCO Power's approved Heartland Generating Station to the electric system. The project involved constructing one single-circuit 240 kV (kilovolt) transmission line (to be named 1181L), approximately 5.5 kilometres long, to connect the approved substation at the ATCO Power Heartland Generating Station (to be named Lamont 400S) to the existing Josephburg Substation. The project also involved substation upgrades at the existing Josephburg Substation.
