ADaMS accounts are for Pool Participants who receive dispatches and/or directives for energy and/or ancillary services from the AESO. The ADaMS is also used to communicate relevant real-time market and system information.

Dispatch Rights and Carbon Copy Rights

There are two different types of rights an ADaMS account can have for assets. The account with Dispatch Rights (DR) to an asset is responsible for acknowledging dispatches and directives for the asset. Consequently, only one account can have the dispatch rights to the asset. If an account has Carbon Copy (CC) rights to an asset, the user will have view only access to the dispatches or directives, and will not be able to acknowledge them. Multiple accounts can be assigned CC rights to an asset
