During this session, the Alberta Electric System Operator (AESO) will present an overview of how the costs of the capacity market should be allocated to loads, exports, and transmission losses using the weighted energy method as prescribed by legislation. The AESO's presentation will include the following key components of its tariff application: time blocks, weights, a rate sheet and terms and conditions. The AESO will also provide an update on tariff design for allocating bulk and regional transmission costs. Participants will have opportunities throughout the session to ask clarifying questions about the information presented.
